HKSAR v. NG Gordon Ching-Hang [2024] HKCFI 3298

Hong Kong 47: Sentencing Order

Decision Date: November 19, 2024

The Hong Kong Special Administrative Region Court of First Instance adjudicated the sentencing of 45 pro-democracy activists, part of the "Hong Kong 47," accused of conspiracy to commit subversion under Article 22(3) of the National Security Law (NSL) and sections of the Crimes Ordinance. The case revolved around a scheme allegedly designed to disrupt government operations by gaining control of the Legislative Council (LegCo) and forcing the Chief Executive's resignation through indiscriminate budget vetoes and LegCo dissolution. While 31 defendants pleaded guilty before trial, 14 were convicted after. The Court, emphasizing a narrow interpretation of NSL penal provisions, rejected the automatic alignment of conspiracy penalties with substantive offenses, instead adopting individualized sentencing guided by local legal principles. The Court dismissed defense arguments of "impossibility" and ignorance of the law, underscoring the conspiracy's seriousness, scale, and public engagement, including the participation of over 610,000 citizens in a related Primary Election. It highlighted that substantial coordination and premeditation invalidated claims of symbolic actions, leading to significant penalties proportionate to the offense's gravity.
